

## Request for connection and notification of the location of gas branch in property/premises

asks Gas Natural Redes GLP, S.A. (hereinafter, *The Distributor*) to execute the connection/s for the gas supply to the aforementioned property according to the conditions expressed below:

1. The gas will be used in the dwellings for general cooking, hot water and heating purposes, and for other commercial or domestic appliances, for which reason, each of the owners of the dwellings or commercial premises of the property, who want the supply, must sign the relevant policy with *The Distributor*.
2. *The Distributor* will execute the connection works to provide the requested supply. The completion of the works will be conditional upon the necessary permits and authorisations being available and the property's receiving installations being complete. *The Distributor* must be notified of this latter circumstance at least thirty days' prior to the completion of the same.
3. The requesting party will be responsible for obtaining the authorisation from the owner of the property or the agreement of the Homeowners Association, where applicable.
4. The executed connection/s, including the connection valve/s, remain the property of The Distributor, it being possible to splice new branches or connections to the pipeline that has been created, as long as the supply to the users is guaranteed.
5. The common and individual installations from the connection valve/s of the buildings will be built as per the instructions, standards and regulations in force for each authorised installation company, duly contracted by the Requesting Party and/or users.  
The receiving installations will be completed before ....., of which the applicant will immediately notify *The Distributor*.
6. For commercial premises, specify appliances and total expected power:

If, on the specified date, *The Distributor* has not received the notification provided for in said point 5 or the supply of appliances expressed in this request has been modified, the same will be cancelled and a new request must be signed, which takes into account the differences in the cost resulting from the passage of time and any other factors that may have an impact in the revision of the financial cooperation established in the previous point.

Likewise, the Requesting Party notifies the Distributor of the planned location for installing the branch at the property address indicated above, by providing the following information:




